## PSCE/CDCR Communication for when we have been notified of batched delayed work:

Thank you for your notification about the delayed work for (CDCR INSTITUTION/YARD/ETC). We will notify faculty of the specific aspects of this batch of delayed work from your institution based on the information you have supplied.

It is important for everyone to have a common understanding of the impact to students around this incident:

- 1. Faculty have the autonomy to make their own decisions about the appropriate flexibility as it pertains to their class. Students can expect that faculty will consider components that are outside their own control and adjust where feasible, especially when it has been specifically outlined in the syllabus.
- 2. When delays happen, there is no guarantee that students will not be negatively impacted even when it is out of their control. Faculty will do their best to take appropriate measures based on
- The amount of information available regarding the delay (specific students, specific assignments, specific dates, etc);
- The length of the anticipated delay;

- Considerations around Academic Honesty; and,
- Concerns pertaining to the course regarding adherence to the Course Outline of Record or other compliance components that could impact the ability to offer the course in the future.

We understand that paper correspondence is a laborious, inefficient process with a lot of opportunities for human error, mishaps, miscommunication, and general aspects of life that are out of anyone's control.
