#### D. MISCELLANEOUS

Resolution 16-05 D-14 – ORDER OF ELECTION FOR BOARD TRUSTEE VACANCY WHEREAS on February 9, 2016 a vacancy on the Palo Verde Community College District Board of Trustees was created due to the death of Francis Theodore Arneson:

WHEREAS pursuant to Education Code Section 5091 and Board Policy 2110, within 60 days of the vacancy occurring, the Palo Verde Community College District Board of Trustees is authorized to make a provisional appointment to the Board of Trustees or call for an election to be held on the next regularly scheduled election date for district governing board members;

WHEREAS pursuant to Education Code Section 5091 and Elections Code Section 1000 the next established election date is November 8, 2016;

WHEREAS pursuant to Education Code Section 5322, the Palo Verde Community College District Board of Trustees is required to provide the county superintendent of schools and the officer conducting the election a resolution that includes the date of the election and the purpose of the election, as well as the authority for ordering the election and the signature of the officer or the clerk of the board;

WHEREAS Education Code Section 5342 and Elections Code Section 10403 authorize the Palo Verde Community College District Board of Trustees to request that the Board of Trustees election be consolidated with other local and statewide elections occurring in the same district or area on the same day;

BE IT RESOLVED that, in accordance with Education Code Section 5091, the Palo Verde Community College District Board of Trustees hereby orders an election to fill the vacancy on the Board of Trustees for the remainder of the unexpired term. In accordance with Education Code Section 5322, the ordered election shall be held on November 8, 2016, to fill a vacancy on the Board of Trustees. The Election is authorized under Education Code Sections 5304 and 5091. The specification of the election order is authorized under Education Code Section 5322 and this resolution is prepared for the signature of the clerk of the board.

#### IV. ACTION ITEM (continued)

BE IT FURTHER RESOLVED that pursuant to Elections Code Section 10403, the Palo Verde Community College District Board of Trustees respectfully requests that the election to fill the Board of Trustees vacancy be consolidated with the statewide election to be held on November 8, 2016. The office to be voted upon shall be: Trustee, Palo Verde Community College District Area 1. The Palo Verde Community College District Board of Trustees hereby acknowledges that the consolidated election will be conducted as prescribed in Elections Code Section 10418.

BE IT FURTHER RESOLVED that the Board of Trustees hereby delegates to the Superintendent or his designee the full authority to consummate the intent of this Resolution, including the authority to execute and transmit, on the District's behalf, any and all required notices under Education Code Sections 5322 and 5342, and Elections Code Section 10403.

Presenter: Martha Crook, BoardDocs Implementation Specialist

Ms. Crook provided background as to what BoardDocs is and does. BoardDocs is a web application that allows users to access the program wherever internet connection is available, and on any device, by going to the BoardDocs website. BoardDocs is also a partner with the California Community College League, and many colleges use the program to conduct their board meetings. Ms. Crook demonstrated the following:

- how to get to the BoardDocs website, www.boarddocs.com.
- login in process and how to change passwords
- the welcome page;
- BoardDocs help, the online manual, and tech support
- an explanation of the tabs Featured, Meetings, Policies, Library, and Search
- how to navigate through an agenda and meeting (a fictitious meeting was created for training purposes for this meeting)
- how to open attachments
- the annotation feature which allows the Trustees to take notes and save them to the cloud
- a mock board meeting

Ms. Crook answered questions from the Trustees, and thanked them for the opportunity to present BoardDocs.
